NTRP 4.5 - All USTA League, A, High School Varsity, Top Club, and Challenge Cup Players. Player is experienced in tournament competition and has strokes that have control, depth and spin.

NTRP 4.0 -All USTA League, B, Middle High School Varsity and Classic Cup Players. Player has done well in club tournaments and flights.

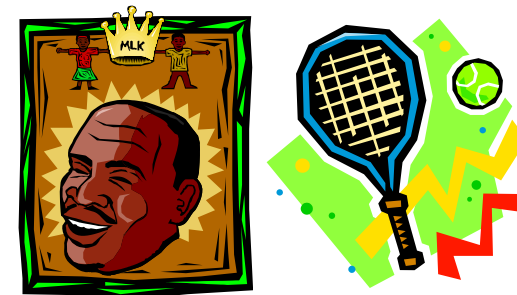

1. Tournament is open to all players. NTRP 3.0-5.0
2. Rules of the USTA observed. 15 minute default time will be enforced, please check in 15 minutes prior to match. Dunlop will be the official tournament ball.
3. All matches will have a 10 minute warm up and follow the USTA League rules. 2 sets, 3rd deuce no add. 12 point tie breaker at 6-6, with a match 10 point tie breaker in lieu of a third set.
4. Draw sizes are limited. Minimum 4 teams per event.
5. Players are limited to 2 events. Doubles teams must enter the division of the strongest player. Mixed events are combined ratings with no more than a 1.0 rating differential in their combined rating.
6. Committee reserves the right to cancel or consolidate any event that draws less than 4 entries. We also reserve the right to refuse any entry.
7. Players are responsible for obtaining their match times. The draw will be posted at www.avantisports.com and @ Mill Creek Tennis Club on Wednesday Jan 13th at 5PM. You can call Mill Creek Tennis Club at (425) 224-4167, Wednesday 5pm-7PM for match times or check the above website.
8. All players must be available for match play Friday 5:00PM-11PM and Saturday, Sunday, & Monday 8AM-11PM. Due to the size and complexity of the draw, **no time requests will be granted!**
